### **Carnival Fantasy Oct. 13-18, 2008**

The Fantasy will sail from New Orleans with ports of call of Progresso and Cozumel. If Costa Maya is open for cruise ships, it may be substituted for Progresso.

15 cabins blocked in 4A inside stateroom \$170.00 + \$174.66 taxes = \$344.66 per person double

30 cabins blocked in 6A ocean view stateroom \$220.00 + \$174.66 taxes = \$394.66 per person double

5 cabins blocked in 12 ocean view suite \$880.00 + \$174.66 per person double

3rd and 4th rates on request

Cabin assignments will be assigned by Carnival after final payment. We will be using points to upgrade the cabins for the group.

Price includes cruise, meals, entertainment and all taxes\* .

\*Fuel surcharges are subject to change without notice.

Gratuities are \$50.00 and can be paid at time of final payment.

Deposit of \$25.00 per person due by Jan. 22.

(The deposit for the cat. 12 suites is \$200.00 per person. )

2nd deposit of \$175.00 per person is due by May 16.

Final Payment due by July 16.

Penalties:

Up to 61 days: None

60- 30 days prior: \$200.00 p.p.

29-08 days prior: 50%

07-00 days prior: 100%

Cancellation insurance is available at an additional cost.

The reservation form is also on the web site. You can bring it with your deposit payment to the meeting on January the 8th, or drop it by Sue's office anytime before the 22<sup>nd</sup> of January. The deposit is \$25 per person.

More details about lodging in NOLA the night before the cruise will be forthcoming. Also, please note the passport requirements:

**New Passport Requirements:**

Beginning January 23, 2007, ALL persons, including U.S. citizens, traveling by air between the United States and Canada, Mexico, Central and South America, the Caribbean, and Bermuda will be required to present a valid passport.

As early as January 1, 2008, ALL persons, including U.S. citizens, traveling between the U.S. and Canada, Mexico, Central and South America, the Caribbean, and Bermuda by land or sea (including ferries), may be required to present a valid passport or other documents as determined by the Department of Homeland Security.
